
Inequities in Healthcare in Arlington

Equity and affordability are not only issues pertaining to housing in Arlington. They are also of concern when it comes to healthcare. In Arlington, chronic conditions (e.g., diabetes, heart disease) disproportionately impact minorities, the elderly, and service workers. According to the Organisation for Economic Co-Operation and Development, 80% of all healthcare costs and 70% deaths pre-covid are due to chronic conditions. Those that suffer from them have a much more difficult time working or providing for themselves. As a result, they are more likely to experience poverty, insecurity, and homelessness.

It is no coincidence that the areas with the greatest healthcare need in Arlington overlap with pockets of poverty. There are four census tracts in Arlington that have more than 469 people on Medicaid, which represents a significant portion of those tracts' population. These census tracts and their approximate neighborhood are:

- 1020.01, Buckingham
- 1020.03, Buckingham
- 1022, Forest Glenn and Arlington Mill
- 1027.01, Douglas Park

The Health Resources and Services Administration has also identified two census tracts (1031 and 1038, Green Valley and Long Branch Creek, respectively) as Medically Underserved Areas (MUAs)—meaning there is a shortage of primary care providers there. This is unacceptable. We should be providing affordable healthcare options to those who need them, where they need them, and with the cultural competency to effectively serve them.

Unfortunately, in Arlington we have just one Federally Qualified Health Center (FQHC). It is located in the 2100 block of Washington Blvd. and can be difficult to get to and from the areas that need it the most. By comparison, Alexandria has six FQHCs spread throughout the city. While Arlington also has the Arlington Free Clinic, the demand for services far exceeds the capacity to provide them.

Arlington needs more Federally Qualified Health Centers and should proactively seek to establish such centers, preferably in or close to the areas that need them. Better still, there is federal funding available to establish these centers. Both public entities and nonprofits can apply for funding to open

What is a Federally Qualified Health Center (FQHC)?

In pertinent part, a FQHC includes:

- Qualifies for enhanced reimbursement from Medicare and Medicaid, as well as other benefits
- Serves an underserved area or population
- Offers a sliding fee scale
- Provides comprehensive services (either on-site or by arrangement with another provider), including:

and operate these centers. But with the federal money comes Health and Human Services (HHS) rules and procedures, which are often informed by rigorous analyses of data and best practices. Ceding control to other entities, even partially, is something the County has traditionally been hesitant to do in many areas of public policy. While this is understandable to a certain extent, it has also caused needless collateral damage to those lacking healthcare access.

- 1. Preventive health services
- 2. Dental services
- 3. Mental health and substance abuse services
- Transportation services necessary for adequate patient care
- Hospital and specialty care
